<b>Technician labor charges*</b>	Hourly rate of <b>\$135.00</b> per technician	
<b>Inspector labor charges*</b>	Hourly rate of <b>\$135.00</b> per inspector	
<b>Engineer labor charges*</b>	Hourly rate of <b>\$200.00</b> per engineer	
<b>Commissioner labor charges</b>	Hourly rate of <b>\$50.00</b>	
<b>Bookkeeper labor charges</b>	Hourly rate of <b>\$85.00</b>
